Agreement for Inmate Housing ("Agreement"), PO #1210278, dated 07/05/2012, between the City of Bellevue and SCORE (South Correctional Entity), as previously amended by:

Amendment No. 1, dated 6/20/2014, Amendment No. 2, dated 06/12/2015, Amendment No. 3, dated 07/31/2015, Amendment No. 4, dated 11/16/2015, Amendment No. 5, dated 08/30/2016, Amendment No. 6, dated 11/16/2017, Amendment No. 7, dated 02/21/2019, Amendment No. 8, dated 6/27/2019, and Amendment No. 9, dated 10/22/2019 is hereby amended as follows:

Date Extension Changes:

The duration of the Agreement shall be extended through 12/31/2020.

Guaranteed Bed and Rate Changes:

Effective 07/01/2019 and continuing through 12/31/2019, the City shall have 15 guaranteed beds at SCORE at a Guaranteed Bed Rate of \$124 and Non-Guaranteed Bed Rate of \$175.

Effective 1/1/2020, the City shall have 25 guaranteed beds at SCORE at a Guaranteed Bed Rate of \$128 regardless of use or bed type and Non-Guaranteed Bed Rate of \$184.

All other terms and conditions of the Agreement shall remain the same.

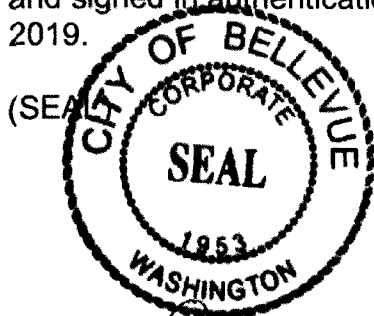
