ORDINANCE NO. 6501

AN ORDINANCE authorizing 1) award of Bid No. 19069, West Lake Sammamish Parkway Phase 2 (CIP Plan No. PW-R-183, W-16) to Pivetta Brothers Construction as the lowest responsible and responsive bidder, in the amount of \$13,124,195.33, plus all applicable taxes, to construct improvements to West Lake Sammamish Parkway from the SE 1900 Block to NE 800 Block; 2) amending the 2019-2025 General Capital Investment Program (CIP) Plan to transfer budget totaling \$1,700,000 from the West Lake Sammamish Parkway Phase 3 project (CIP Plan No. PW-R-194) to the West Lake Sammamish Parkway Phase 2 project; and, 3) increasing the 2019-2020 General CIP Fund appropriation by \$1,700,000.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

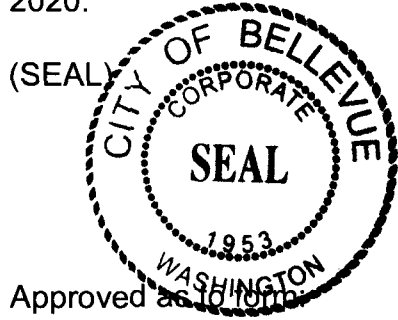
Section 1. Bid No. 19069, West Lake Sammamish Parkway Phase 2 (CIP Plan No. PW-R-183, W-16) is awarded to Pivetta Brothers Construction as the lowest responsible and responsive bidder, in the amount of \$13,124,195.33, plus all applicable taxes, to construct improvements to West Lake Sammamish Parkway from the SE 1900 Block to NE 800 Block.


Section 2. The City's 2019-2025 General Capital Investment Program (CIP) Plan, adopted by Ordinance 6493 on December 2, 2019, as previously amended, is hereby further amended to transfer budget totaling \$1,700,000 from the West Lake Sammamish Parkway Phase 3 project (CIP Plan No. PW-R-194) to the West Lake Sammamish Parkway Phase 2 project.

Section 3. The City's 2019-2020 General CIP Fund, adopted by Ordinance 6493 on December 2, 2019, as previously amended, is hereby further amended to increase the appropriation by \$1,700,000.


Section 4. This Ordinance shall take effect and be in force five (5) days after its passage and legal publication.


