

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6504

AN ORDINANCE amending Ordinance No. 3990 to modify the hours of the parking restrictions and extending the boundaries on an as needed basis along SE 47th Street east of 139th Avenue SE to the end of the cul-de-sac.

WHEREAS, Policy TR-149 of the Transportation Element of the Comprehensive Plan states that City will minimize spillover parking into residential neighborhoods through residential parking zones and other measures; and

WHEREAS, over the past 30 years, the Transportation Department has worked with residents to address their concerns with public nuisances occurring on SE 47th Street; and

WHEREAS, in 1989 the City Council passed Ordinance 3990 to restrict the parking of vehicles on SE 47th Street; and

WHEREAS, since the passage of Ordinance 3990 to restrict the parking of vehicles, residents have continued to have concerns with public nuisances occurring on SE 47th Street; and

WHEREAS, modifying the hours of the parking restrictions and extending the boundaries of the parking restrictions on an as needed basis along SE 47th Street proactively allows the city to be more responsive and expeditious in responding to parking concerns when they occur. now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 1 of Ordinance 3990 is hereby amended to read as follows:

Parking, standing, or stopping is prohibited on SE 47th Street east of 139th Avenue SE on the north side between 139th Avenue SE and the westerly lot line of 13928 SE 47th Street and on the south side between 139th Avenue SE and the westerly lot line of 13921 SE 47th Street during the hours of 9 pm to 5 am daily.

Section 2. Section 2 of Ordinance 3990 is hereby amended to read as follows:

The City Manager, or designee, is hereby authorized to establish parking restrictions on an as needed basis along SE 47th Street east of 139th Avenue SE to the end of the cul-de-sac. Such parking restrictions shall be filed and maintained with this Ordinance by the City Clerk in accordance with Bellevue City Code 11.23.010.


Section 3. This Ordinance shall take effect and be in force thirty (30) days after its passage and legal publication.


